(1) OPERATIONAL CHECKS							EC2	
INSPECT THE UPPER FRAME OPENING AND CLOSING MOVEMENTS								
INSPECT BOTH LOCKING PLUNGERS OPERATE SMOOTHLY AND LOCK THE UPPER FRAME INTO OPEN AND CLOSED								
POSITIONS								
INSPECT THE SEAT FRAME OPENING AND CLOSING MOVEMENT OPERATES EASILY / SILENTLY								
THERE SHOULD NOT BE ANY FRICTION BETWEEN THE STUB TUBES AND INSIDE THE TRACKS								
INSPECT THE TELELSCOPIC GAS STRUT OPENS AND CLOSES THE REAR FRAME SMOOTHLY AND IF FITTED THE BRAKE								
CABLES ARE CLEAR IN THIS OPERATION BETWEEN THE CARRY HANDLE FRAME AND LOWER FRAME								
HANDLE								
INSPECT THE BRAKE HANDLE OPERATES BOTH BRAKE CABLES SMOOTHLY AND CHECK EACH RUBBER TRACK RUNS								
FREELY OR HELD IN THE STOP POSITION (REFER TO EVACUSCAPE VIDEO)								
INSPECT THE 5 POINT SAFETY HARNESS AND HEAD STRAP SUPPORT WORKS CORRECTLY								
INSPECT THE SEAT BELT FIXING POINT HAS SECURING WASHERS FITTED								
INSPECT THE SAFETY LIGHT WORKS CORRECTLY								
INSPECT BOTH REAR CASTORS SWIVEL AND BRAKE								
INSPECT BOTH QUICK RELEASE WHEELS ARE SECURE AND ROTATE SMOOTHLY								
INSPECT THE TRACK BRAKING SYSTEM WORKS AND IS ADJUSTED CORRECTLY								
(2) SURFACE FINISH CHECKS						EC1	EC2	
INSPECT ALL FABRIC PARTS FIT CORRECTLY AND DO NOT HAVE ANY TEARS OR LOOSE STITCHING								
INSPECT ALL SAFETY BELT FABRIC PARTS FIT CORRECTLY AND DO NOT HAVE ANY TEARS OR LOOSE STITCHING								
INSPECT UPPER + LOWER FRAME HEAT SHRINK COVERS ARE FITTED CORRECTLY AND DO NOT HAVE ANY TEARS OR								
DAMAGE ON THE SURFACE								
RUST FREE								
INSPECT THE BRAKE HANDLE PART IS FITTED WITH A NEW HEAT SHRINK COVER AND POSITIONED CORRECTLY								
INSPECT SILVER PAINTED FRAMES AND TRACKS ARE IN GOOD WORKING CONDITION								
INSPECT ALL SAFETY LABELS / INSTRUCTIONS ARE CLEAR AND EASY TO READ								
INSPECT BOTH RUBBER TRACKS ARE CLEAN AND WITHOUT ANY DAMAGE								
INSPECT BOTH REAR CASTORS ARE CLEAN AND WITHOUT DAMAGE								
INSPECT BOTH QUICK RELEASE WHEELS ARE SECURE AND ROTATE SMOOTHLY								
(3) CHAIR STORAGE LOCATION						EC1	EC2	
CHECK THE LOCATION OF THE EVACUATION CHAIR, IT SHOULD BE CLOSE TO THE STAIRWAY, SECURELY MOUNTED								
TO A WALL WITHOUT RESTRICTING ANY OF THE WALKWAY								
CHECK THE WALL MOUNTED EVACUATION SIGNS ARE IN PLACE AND CLEAR TO READ								
INSPECT THE WHITE DUST COVER FITS CORRECTLY AND DOES NOT HAVE ANY TEARS OR LOOSE STITCHING
